PMT() is a function used in Excel to calculate payments due on a loan, assuming a constant interest rate and constant payments.

Choose the Trace Dependents in the Formula Auditing group in the Formula tab. The Trace Dependents option is used to see which formulas refer to the value in the selected cell. Answer option B is incorrect. The Trace Precedents option is used to see which cells provide values for the formula in the active cell. Answer option A is incorrect. It will not accomplish the task as Watch Window is used to monitor the value in a cell. It provides users a convenient way to inspect, audit, or confirm formula calculations and results in large worksheets/workbooks. Answer option C is incorrect. Evaluate Formula is a tool for examining formulas that do not produce an error, but also not generating the expected result. Reference.
